On acceptance of an offer of admission, this information will be entered to the Primary Online Database. The Primary Online Database (POD) is a nationwide individualized database of primary school pupils, hosted by the Department of Education and Skills.

In the event of oversubscription, a waiting list of students whose applications for admission to Scoil Mhuire agus Iosaf National School were unsuccessful due to the school being oversubscribed will be compiled, and will remain valid for the school year in which admission is being sought (see section 13 – or relevant section – School Admission Policy).
